GENERAL BUSINESS:

1. Transporter Driver: a discussion was held regarding the driver of the transporter for the 2026 season, Rex was informed of the conditions the club would ask of him when conveying the club's birds for the west schedule, and was asked to state the cost per trip for him to drive, given the approved club schedule for west route 2026, Rex did also state that he would like another volunteer member to assist him on the two night races, with no further business to discuss with Rex, he left the meeting @ 11.40am.

Further discussion was held and a decision reached.

MOTION

- Fee for one-night races to be \$100.00 per trip.
- Fee for two-night races to be \$200.00 per trip with accommodation and meals paid by the club when required.
- The driver to be given written instructions from the liberation committee chairperson for each race.

Moved Gary Bryant and 2nd Brendan Powell, all in favour, motion carried.

2. Race Schedule: a discussion was held regarding the protocol that would be implemented to ensure that the welfare of the driver and the birds in his charge, and due to the club's by-laws, timeframes would have to be considered in order to provide a level of care to both, Mitchell race point was flagged as a concern regarding hours driven and standing time which could not be done safely if going overnight.

MOTION

- Following race points to be designated two-night races: Mitchell, Morven, and Charleville.
- Marking start time for all races is to be 17.30 on designated marking night.

Moved Gary Bryant and 2nd Nigel Dickinson, all in favour, motion carried.

ACTION: Secretary to draw up a schedule to include all relevant information.

3. Application form: a new application form has been drawn up by the secretary to encompass the need to inform potential new members that under Model Rule 9.2 the club is required to inform them that the club has public liability insurance and state the value and to remove the 12-month probationary period stated on the current form.

MOTION

- That the current form be repealed and the new form be the official new member application form of the BRPC Inc as of 1st March 2026.

Moved Glenn Cross and 2nd Nigel Dickinson, all in favour, motion carried.
