St Marys delegate explained to the meeting the reason for the request for a refund for several members of their 1st Derby Call.

MANAGEMENT COMMITTEE MEETING:

The minutes of the Management Committee meeting held on the 3rd June 2013 as tabled were received, moved by K.Gambell (MTD) seconded by P.Murphy (CTN). Carried.

BUSINESS ARISING: Nil.

Adoption of the Management Committee minutes moved Seven Hills seconded by Regents Park. Carried.

The minutes of the Management Committee meeting held on the 17th June 2013 were read to the meeting and received on a motion moved by J.Jones (HD) seconded by P.Murphy (CTN). Carried.

BUSINESS ARISING:

Campbelltown delegate spoke on the Committee report on the 4th Kelso liberation and put forward the following suggestions: (i) Re visit the liberation protocol and improve it to safe guard the pigeons. (ii) Build in safety margins. (iii) Check all weather conditions on a wider scale.

Regents Park delegate spoke on the cancellation of the 3rd Orange race. It was explained as there was less than a 50% chance of liberating the birds on the Sunday the driver and liberator was not available for Monday liberation due to prior commitments. In the short series the driver is employed for basketing Friday night for a Saturday race, in event of a holdover and liberate on the Sunday or return the birds home, thus the driver is not committed for a Monday liberation. This arrangement changes once Thursday night basketing commences. It was pointed out the need of a backup driver and liberator in matters like these. Management Committee will investigate the need of a backup driver and liberator.

BUSINESS FROM THE CLUBS:

Blacktown - delegate spoke on the proposed \$1 life ring, would be in favour if the profit was to assist in reducing fees and queried the following: (i) cost of unsold rings, (ii) charging two years old birds.

Campbelltown City - delegate informed the meeting the following: (i) first squeaker sale race -3^{rd} Condobolin. (ii) 2^{rd} squeaker sale race -2^{rd} Hillston. (iii) will be holding a Friday night Squeaker Sale this year, rings will be available in lots of 5 more details coming.

Punchbowl/Bankstown – delegate also spoke on the \$1 ring proposal (i) why should the larger purchaser of rings subsidize the smaller purchaser. (ii) could mean a drop in the sale of rings and loss of members. (iii) would the added prize money be evenly split over the six races? (iv) cost to the clubs of unsold rings? (v) also stated the club does not support the two birder due to the 7.00pm ring off time. (vi) spoke on the conditions required for the juniors. (vii) spoke about the Federation to be consistent in dealing with members being accused of misbehaviour. (viii) queried basketing arrangements for the derbies.

Seven Hills – delegate spoke on having two races on this upcoming weekend as the weather looks to be good. The President John Hubble stated that he has been in touch with the driver and he is ok to do a double this weekend. The majority of the delegates present were in favour of the two races this weekend. The Management will discuss this further at their meeting.

St Marys – delegate reported that they are missing a basket from the 1st Orange race. Delegates were asked to check their Club room for any stray baskets and return them.
