Blacktown delegate spoke on their motion to revert back to the original west route, other delegates also spoke on this and on some of the race points on the new west route where the birds would have to face high parts of the Great Dividing Range to home. Kur Ring Gai delegate stated the previous ruling should be reconsidered and in future, rule in accordance to our current Constitution and Rules. The President stated that a survey team will be surveying all the possible race points on the new west route for suitability.

After further discussion on the matter and a request to have a special Meeting (Vote) it would need to a have a Notice of Motion to this effect moved by one Club and to be seconded by six other Clubs. As the year is fast running out it was then decided to have a Club delegate present move the motion and have six other Clubs present second the motion. It was then moved by the Dural delegate and seconded by the following delegates Ku Ring Gai, Marayong, Merrylands, Parramatta, Mt Druitt Seven Hills that the following motion be submitted.

"The 2019 season west route to be flown from the last CCF west route flown". This motion will now be sent back to the Clubs for a final vote by their members. Results are to be returned to the Federation meeting 5th November 2018. If this vote fails to have a majority vote in favour the 2019 west route will be the new west route (Line Sydney to Renmark).

The minutes of the Management Committee meeting held on the 11th September 2018 as issued were received moved Anthony Aguis (SUTH) seconded by Kevin Gambell (MQH). Carried.

Adoption of the minutes moved Riverstone seconded by Parramatta. Carried.

GENERAL BUSINESS:

Motion re: tossing surplus bird's half hour after normal liberation – 98 in favour, 68 against. Carried.

Motion re: one flyer per one address – 78 in favour – 86 against. Motion defeated.

With Vince Pedavoli resigning from President position, it was moved by Blacktown and seconded by Rooty Hill that Phil Murphy be endorsed as President for the remainder of the 2018 season. Carried.

- a. Bossley Park delegate queried how long does it take to survey the race points? 2-3 days.
- b. Sutherland delegate reminded the delegates present of the one bird race from Gundagai this Saturday 6th October 2018. Basketing Maroubra Club Room 5th October 6PM 9PM. Ring off 7PM Maroubra Club Room.
- c. The President stated the following: To change any current rule a notice of motion to that effect must be moved by one Club and seconded by a second Club. Must be signed and dated by the Secretary and President of both Clubs. A copy of the minutes showing where the matter was discussed and passed by each Club must be presented along with a copy of both Clubs members register showing the date of such meeting.
