BUSINESS ARISING: A general discussion on the life rings, several delegates spoke and gave their opinion on the matter. A motion was then moved by the Punchbowl/Bankstown delegate and seconded by the Hills District delegate that the Management Committee decision that all 2014 life rings be the icom ring be rejected. Clubs are to be given the choice of choosing the icom ring or the normal type life ring. New order forms are to be sent to the Clubs for this purpose and are to be returned by the 2nd December 2013. The motion was carried 16 votes to 0, some delegates abstained from voting.

Adoption of the Management Committee minutes moved Parramatta seconded by Rooty Hill. Carried.

GENERAL BUSINESS:

The Secretary John Jeffery gave the final vote result on the proposed schedules for the 2014 season.

The schedule submitted by the Management Committee received 156 votes compared to the St Marys submitted schedule which receive 47 votes.

It is to be noted that the adopted schedule for the betterment of the pigeons may be reshuffled to allow the two longer races to be held a little earlier than usual. Any alteration will need to be approved by the general membership.

Punchbowl/Bankstown delegate queried as points were credited to the cancelled Mingary races, will this become the normal procedure. If the birds are sent to a race point and then cancelled, points will be credited for that cancelled race.

Oxley Park delegate suggested that the Federation should form a Sub Committee to look into the viability of conducting a long distance race programme, prestige racing for those members who like the long distance races. Not to be part of the normal schedule. Several other delegates spoke and expressed their opinion on this matter.
