My proposal is to cancel the Monday long weekend race as most fliers that have contracted the rota virus of late do not have enough old birds to compete in the two races scheduled therefore numbers will be down on one or both the races of the long weekend. The scheduled Gunning race can be rescheduled for Saturday 30/6/18 and the last Holbrook 15/9/18 be cancelled and replaced with an extra Gundagai taking place on Saturday 7/7/18 this will take the season one week longer than scheduled. I hope that this proposal is seriously considered in the best interest of the birds welfare and to show the CCF members that the federation committee are doing everything to improve pigeon racing and moving on with the times, thank you yours in the sport".
