Motion moved Campbelltown seconded Marsfield that the Federation Young Bird is to be included in the long series point score, however the birds are included in Young Bird Point Score. Carried 25 votes to 3 votes.

The above was accepted on a motion move by Bob Coles (LIV) seconded by Pat Arcella (DURAL). Carried.

#### SIGINING OF THE DEPARTMENT OF FAIR-TRADING FORM:

Motion moved Paul Vassallo (MPS) seconded by Pat Arcella (DURAL) that Phil Murphy signed the Department of Fair-Trading document. Carried.

### CONSTITUTION & RULES OF THE FEDERATION:

Motion Moved Motion moved Peter Collins (MARS) seconded by Pat Arcella (DURAL) that the current constitution and all the current rules of the Central Cumberland Racing Pigeon Federation Incorporated with the alterations adopted tonight, be adopted for the 2021 season. Carried.

#### **GENERAL BUSINESS:**

- 1. Warren Schofield advised that due to problems that occurred in 2020 where some members complained about the birds either being either liberated or held over, that all members be aware of the Liberation Protocol to avoid confusion in the future. A copy of the Federation Constitution and Racing Rules is on the website, however a copy will be emailed to each Club Secretary.
- 2. Moved Maroubra seconded Regents Park that surplus birds be liberated with the race birds. Amendment moved Bossley Park seconded St Mary's that surplus birds liberated 30 minutes after the race birds. Prior to voting, it was moved Dural seconded Merrylands that the Geraldy trailers be used for the 2021 season. Several members spoke on the issues of using the Geraldy trailers instead of the old CCF trailer. It was explained to the meeting that due to the numbers nominating to race, that surplus would not be possible on the Geraldy trailers as these trailers catered for 216 baskets in comparison to the old trailer of 334 baskets.
- 3. Several members spoke on the need to send surplus birds in order that they be fully educated and fit for the North route. Other members were against surplus birds influencing the race birds.
- 4. After a lengthy discussion, the members voted on which trailer to be used Geraldy trailers 18 votes, old CCF trailer 12 votes. Geraldy trailers to be used 2021 season. Carried.
- 5. Moved Sutherland seconded Bossley Park that any body tossing at the race point should be at least 10 kilometres from the race point and should liberate 30 minutes after the race birds. A three (3) week suspension should be served on any member not abiding. Vote 19 votes in favour, 3 votes against. Carried.
- 6. The Federation bird limit was then discussed, and it was moved Dural seconded Liverpool that a 30-bird limit apply. An amendment was moved Maroubra and seconded Smithfield that it be 25 birds. A further amendment was moved Sutherland seconded Blacktown that the bird limit be 20 birds. A vote was then taken between the two amendments 20 birds 9 votes, 25 birds 11 votes.
- 7. A further was then taken amendment for 25 birds 22 votes, 30 birds 11 votes. Bird limit 25 birds per member.
- 8. Nick Kaparos and Sam Sultana gave an update on the Geraldy trailer updates: Report attached.
- 9. Gary Donovan asked the Federation would complete the season on the North route. Answer yes.
- 10. Dave Gordon enquired if due to bad weather and a race was postponed what was the procedure? Answer the race would be slotted in where possible.
- 11. Milad Bou-Said asked did the President have any input in the liberation of the birds. Answer NO. However, if the Liberation Committee could not agree with each other, the matter is referred to the executive
- 12. Steve Shears advised that The Australian War Memorial in conjunction with the ANRPB is conducting a display on the 24/2/21 about Animals in War. Anybody interested in the event can book online or contact Steve Shears for further information.
- 13. The Presentation Night was discussed, and three (3) venues were suggested, Guildford Leagues Club, Merrylands Bowling Club, and Dooleys Club. It was suggested that a fully catered meal be provided at whatever venue is chose. Enquiries will be made a reported back to the next meeting.
- 14. The President advised that if members have problems or issues, that they should come to the Federation Meetings to discuss them and not have "backyard meetings".

#### CCF GERALDY TRANSPORTER REPORT

The CCF Geraldy transporter was inspected on the 18-21-2020 and 28-1-2021.

The inspections were carried out by Sam Sultana and Nick Kaparos being the elected members of the Truck Committee.

The purpose of the inspection was to test the transporters air system to ventilate the transporter and also reduce the heat load during transportation (motion) and when the transporter is stationery (parked).

### The Transporter

The transporter comprises of two (2) standard geraldy transporter units connected together.

Each standard unit has six (6) basket bayseither side of the unit with a central corridor for feeding and watering the birds.

The front section of the transporter has sleeping quarters which take up two (2) basket bays, leaving four (4) basket bays, followed by a further six (6) basket bays past the connection point of the two units.

# **Ventilation System**

The transporter has three (3) separate ventilation systems as follow;

- 1. Transporter roof has nine (9) skylights which can be opened when the transporter is in motion or stationery to ventilate the central corridor of the transporter.
- 2. A plenum air system operated by four (4) fan forces air via ducting and tubing system from the front of the transporter to the back of the transporter.
  - The aluminium tubing which is approximately 35mm to 40mm in diameter is perforated at the top of each basket delivering some amount of air to each individual basket depending on the location of each basket.
- 3. The transporter has thee (3) roof fans which pull in fresh external air and force the air downwards to ventilate the central isle.

### **Testing**

The skylights which can be opened and rotated in the direction of travel or opposite the direction of travel were not tested as the transporter was stationery during the inspection.

The plenum system which delivers air to each individual basket was the prime focus of the testing.

The plenum system comprises of four (4) fans sucking air from the front of the transporter into a ducted funnel under the transporter roof and is situated over the sleeping quarters of the transporter. The air is directed to a horizontal metal duct approximately 600mm x 300mm in size. The horizontal ducts directs the air into a vertical duct approximately 600mm x 100mm in size, situated on the basket side of the dividing wall between the sleeping quarters and the basket rack system of the transporter.

The air is distributed to each rows of baskets by a 40mm diameter plastic tubing connected to a series of top to bottom offtakes from the 600x100mm vertical air duct. The offtakes are located in line with the horizontal aluminium tubing delivering air to each individual basket.

At the connection point of the two transporter units the air is delivered to the rear unit by a 40mm diameter tubing in a U-shaped configuration. The vertical plenum offtakes were tested by removing the tubing from the offtakes and testing the amount of air being delivered to each row of baskets.

The top offtakes from the vertical plenum duct delivers the most air and as you disconnect the offtake tubing from top to bottom the amount of air delivered reduces. In other words the top rows of baskets receive the most air and the bottom rows of the basket receive the least amount of air.

In order to determine how far towards the rear of the transporter air was being delivered, a flame test was used to see if the air could be detected that was able to flicker the flame of a lighted match or disburse the smoke from a lighted match.

As there are 10 basket bays for testing purposes, basket bay 1 is at the front of the transporter and basket bay 10 is at the rear of the transporter.

Results of the flame testing and smoke distribution are as follows:

- The front six (6) basket bays all showed satisfactory forced air to each basket,
- The 7<sup>th</sup> basket bay showed satisfactory air for all but the bottom two (2) baskets where no air could be detected,
- The 8<sup>th</sup> basket bay showed satisfactory forced air for all but the bottom three (3) baskets,
- The 9<sup>th</sup> basket bay showed top baskets with satisfactory air and bottom five (5) baskets with no air detected.
- The 10<sup>th</sup> basket bays showed top two baskets with satisfactory air and bottom six (6) baskets with no air detected to baskets.

The testing demonstrates that 32 out the 160 baskets receive no air at all. Its is also estimated that an additional 14 baskets which receive detectable air but of insufficient air volume to ventilate bird numbers exceeding 16 birds per basket.

The roof fans were tested and found to suck in sufficient fresh air to reduce the temperature of the central transporter isle by approximately 10c when the transporter is fully loaded with pigeons.

#### **Data Loggers**

In order to test the quality of the air inside the fully loaded transporter it was proposed to purchase and install portable data loggers which could be moved around inside the transporter to test and record the quality of the air during transit.

#### **Recommended Remedial Measures**

The air system is currently manually operated with no back up battery system to allow the air system to operate for a prolonged period of time.

In order to improve the air system and reduce the build up of heat the following alternative options are proposed.

### Option 1

- Provide four (4) additional 12v batteries fitted in series to the transporter to operate the plenum fans and roof fans.

It is estimated when fully charged the batteries can operate the air system for 8 hours without requiring to be charged.

- Provide chargers for all transporter batteries to re charge from the prime mover.
- Supply and fit a separate timer system for the plenum fans to operate the fans at specified time intervals.

- Supply and fit a separate timer system for the roof fans to operate the fans at specified time intervals.
- Power outlets fitted to the transporter to provide power to data loggers secured to transporter corridor, for the purpose of monitoring air quality.

#### Option 2

Remedial works are in progress as per Option 1.

In the event that information collected from the data loggers, consistently shows that the air inside the transporter is detrimental to the health and well being of the birds, the following option is proposed: Remove the plastic basket doors and replace them with small gauge wire doors.

The advantage of this option is that all baskets will receive an equal amount of cross ventilated natural air flow without disadvantaging any baskets.

The additional advantage is that you are not reliant on fans, batteries and timers to operate the mechanical air flow system which may break down and also eliminate periodic maintenance and replacement costs. The disadvantage to this option is that the up front cost is double the Option 1 costs.

### **Operational Recommendations**

### Transporter in motion

- -Roof skylights shut
- Roller shutter door shut and shutter slits to remain open.
- Plenum fans and roof fans operating intermittently to expel stale air and reduce the build-up of heat
- Monitor temperature and air quality via the data loggers

### **Transporter Parked**

### **During The Day**

- Roller shutter doors open and rear door open
- If weather is fine open skylights to allow hot air to escape
- Manually operate roof fans and plenum fans if internal transporter temperature exceeds 25C.

### **During The Night**

- Close roller shutter doors, making sure that shutter slats remain open
- Close skylights
- Close rear door
- Operate the plenum fans intermittently via the timer system
- Operate the roof fans intermittently via the timer system
- Monitor the temperature and air quality via the data loggers
- Air quality output information to be sent to a qualified veterinarian for advice on the suitability of the ambient air in the transporter
