## **AUDITORS EPORT/BALANCE SHEET:**

The Balance Sheet as supplied was discussed and the Federation Auditor, Rodney Wagner, spoke on the financial position of the Federation. Rodney advised that the Federation was in a strong position however suggested that depreciation of vehicles could be looked at in the future following a question by Dave Tomkinson (CTN).

At present, the Federation has a vehicle depreciation of 10%, reducing the depreciation amount would allow for a possible reduction of fees. The Federation recorded a profit of \$2758.38 after depreciation and a member's credit of \$5000 for the coming season together with \$2100 carried over from 2018. The rebate to flyers will be proportionate with the short season and full season 2019 flyers. Members who flew 2019 and are not flying the 2020 season will not be eligible for any rebate.
