**MANAGEMENT COMMITTEE MEETING: 2<sup>nd</sup> September 2013.**

**AGENDA:**

**Meeting with the St Marys Club representatives:**

The St Marys representatives explained further on the letter that was emailed to the Secretary re the submitting of the 2014 race schedule. They explained that everything was carried out in accordance to the current CCF rules and the majority of the members were approached in regard to submitting the schedule. After a general discussion it was decided by the Management that the schedule was acceptable.

It was then decided by the Management that the closing date for the return of the voting on the proposed schedules be extended until the 7<sup>th</sup> October 2013. Now the Clubs have been issued with a map showing the new race points as proposed by the Campbelltown City Club. Any Club that has forwarded their voting sheets to the Federation and has a member wishing to alter his/her vote that Club must notify the Federation Secretary and do a revote.

It has been advised that the Victorian Federations liberating at Hillston on Saturday the 7<sup>th</sup> September 2013 will allow the CCF to liberate first and they will liberate 30 – 45 mins after the CCF. It is anticipated that the CCF will liberate at 7.00 am (half hour after local sunrise 6.29am) depending on the weather and light conditions.

The following Email advice was received from the DPI.

PPMV1 has been diagnosed in non-feral pigeons in the Warrawong area of NSW. Owner reported the loss of more than 30 birds.

Vince Pedavoli advised the Management that he has been in contact with DPI and the birds effected by PPMV1 were fancy pigeons.

The Secretary John Jeffery informed the members that everything is set for the Young Bird Derby ring off at the Guildford Leagues Club. It is hoped that members from the Clubs come forward to lend a hand if required. The setting up will commence at 6.00 pm. Electronic Clocks will commence ringing off at 7.00 pm. Manual Clocks will be rung off at 8.00 pm. Everything going to plan results will be displayed on the overhead screen.
