# MANAGEMENT COMMITTEE MEETING: 12<sup>th</sup> November 2012

**PRESENT:** John Hubble, John Jeffery, Kevin Gambell, Paul Vassallo, John Migdalski, Vince Pedavoli, Jeff Jones, Victor Borg, Bill Eastcott, Nick Kaparos, George Ibrahim and Warren Schofield – Liberation Committee member.

## Minute Secretary: Allen Wonson.

The following topics discussed:

- 1. Storage of the liberators vehicle during the off season was discussed. Vince Pedavoli offered to store the vehicle.
- 2. The 2012 social and presentation evening has been rescheduled for Saturday 2<sup>nd</sup> March 2013 venue Guildford Leagues Club. Tickets will be available at the Federation Annual General Meeting. (17<sup>th</sup> February 2013).
- 3. Vaccinating of the birds for the 2013 season was discussed. It was moved and seconded that all Clubs will be requested to fill out a register that will be supplied by the Federation. The names of each competing member in each Club must sign this register, stating that he/she has vaccinated their birds twice and at least one month apart against PMVI virus. This register is to be returned to the Federation two weeks prior to the first race of the 2013 schedule and is to be counter signed by the Club President and Secretary
- 4. Phil Murphy has offered \$500.00 for each of the 2013 Derbies. The exact form of distribution will be discussed with Phil.
- 5. There was a general discussion on the adopted schedule and some of the race points. All race points up to Condobolin are subject to being checked for suitability and accessibility.
- 6. Nick Kaparos spoke on the weather conditions during the later part of the 2012 season that could have contributed to the poor returns. From the Young Bird Derby and onwards each weekend seemed to have adverse winds against the birds, where earlier in the week the wind would have been favourable for the birds. Nick suggested that may be the Federation should be looking at changing basketing of the birds to such a night that the birds may have favourable winds on the liberation day this could mean basketing for a week day race. The slower velocities and the falcons would also have an affect on the returns.
- 7. The Secretary John Jeffery reported that he had been contacted by the RSPCA in regards to a complaint made to them by a member of the Federation in regards to the hot weather on the weekend of the first Bourke. John explained to the RSPCA representative the conditions and the care of the birds whilst in transport and at the race points. John also supplied a copy of the Federation Liberation Protocol and the latest temperature reading which is monitored by the liberator. The RSPCA representative stated that they had no problem with the conditions and could not understand why the particular flyer complained to them instead of the Federation. John also invited the RSPCA representative to attend a loading of the birds at Fairfield.
