1. Welcoming of Members Present

The Chair welcomed the members present. Jeff Formosa, Wayne Weatherburn, Alan Zahra, Dave Miller, John Banfield, Terry Condran, Anthony Agius, John Borg, Rudy Diener, Peter Clark, Jeff Shepard, Tony Davis, Trevor Gassling.

3. Presidents Report

The Chair advised that we have had a very successful race from Eden with all sections trapping. The Leslie Vale race was more challenging, regarding the weather conditions which required that the birds to be held over for 10 days. In the end we got a window to liberate the birds. In the end the race was won, 2 birds were trapped on the south coast in reasonable time, as well 3 birds at Moruya. There were several birds trapped in all sections, but unfortunately out of race time.

He advised that Long Distance racing was not easy, and requires good birds, that can take on the challenges. He said that it is pleasing to see that there is renewed interest in breeding pigeons that can compete at the distance, all we need is to get some good luck on our side.

He thanked the committee, the sponsors, members for their ongoing and continued support for without such support we would not be able to make the races viable and affordable to all. Dave advised that he has been having health issues but will continue in the role as Chair, if re-elected.

4. Secretaries Report

The Secretary advised that the administration side of the club, planning, preparing, basketing and delivering the birds on time for both this year's races went to plan.

Eden went smoothly with reasonable returns, and Leslie Vale all went to plan arriving at the liberation points on time without issue.

Regarding Leslie Vale race, he advised that the main issue was the weather, as a member of the Liberation Committee I, as well as Frank Rachilla, Pat Arcella and Robin White were on the phone every day looking for a suitable window to liberate. This was a challenging task for all involved and urged members to understand and respect the critical role and responsibilities that each member takes on once elected to the position.

He agreed with the Chairs comments that we just need a bit of luck to go our way, and hopefully we will have a successfully season in 2023.

5. Business arising from correspondence.

The Secretary advised that this email was received well after the closing date of the agenda, which was the 19/2/23. Notice of AGM was provided to all members via text message on the 1/2/23.

There was a lot of discussion regarding the proposed boundary change. The Chair advised that he believes that this should be ruled out of order as adequate notice was not provided and as such was not included on the agenda.

John Banfield asked that the letter be discussed. Alan Zahra asked what the issue was about. The Secretary explained that the Hunter Club is able to fly in both the NCF and Central Coast Feds, some fly in both feds others only fly in the Central Coast.

The Chair advised that the boundaries were set by the ECLDRC, stating that Hunter flyers are included in the NCF boundary as he believes that's how it will remain unless it is change by majority vote.

John Banfield suggested that the Hunter flyers could be given an option as to what boundary they compete in. This started a discussion regarding over fly, fairness, who has the advantage etc.

The Secretary advised that it doesn't worry him personal which section they fly in, but he advised that Garry Pound had raised concerns after the first race from Peterborough that the Hunter Club should be in the NCF section. At the time there was no objection to the Hunter being included in the NCF boundary.

The Chair advised that this is not what we should be discussing as we have set our boundaries. The Chair eventually allowed a vote, which was 6 for the proposal and 4 against.

Note – The next day the Chair contacted the Secretary and advised that he has received a complaint that he had allowed a vote to proceed on the proposed boundary change. He advised that as it was not on the posted agenda, and as all members were not aware of the notice of motion, it should have been noted in the minutes as received and be added to the next General Meetings Agenda as required by the club's constitution.

The Secretary confirmed that that is the correct procedure.

A phone hook up was held with the other members of the committee, they were advised of the error, and it was agreed to have it discussed and voted on at the next meeting.

The Chair, Secretary and Vice President contact Mick Scroggy by phone call and advised him of the decision.

7. Proposed Race points - East Coast Classic - Red Rock, Bundaberg, Peterborough
