Due to their not being a delegate or Cowra/Woodstock club member present who could discuss these issues on there behalf it was agreed by the members present that the motion be postponed until MWPF AGM meeting.

Treasures Report: The Treasures report (See Attached Doc) was read by Dave Graham. D Byrnes moved a motion that the treasures report be accepted, Seconded E Strudwick.

General business

- It was discuss amongst the members that a MWPF liberation trailer be acquired, either by the purchase of a new unit purposely constructed or a second hand unit which can be adjusted to suit the needs of the MWPF. Ed Strudwick said he would follow up on options.
- Dave Graham presented Documents regarding disciplinary action which are to be discussed and amended at a later special meeting.

Motion put forward by Cowra/Woodstock Club

I have been asked by the Cowra Woodstock Racing Pigeon Club after our club meeting on the 1st November as Club Secretary to submit a motion for the meeting agenda in case our members are unable to attend the meeting

1. The Cowra Woodstock Racing Pigeon Club puts a motion forward that the Dubbo (also includes Trangie & Nevertire if flying) birds be released separately to the Midwest Federation birds with the possible exception being the final race point

It is our belief that releasing with the much shorter Dubbo club severely affects the returns of the longer clubs who are sending far less bird numbers raising concerns of bird welfare

It is also our belief that releasing with Dubbo severely affects Federation results & that no other fed would release jointly with a non federation club if it had such an impact on federation results, you only need to compare Dubbo velocities with those of the longer clubs eg Cowra Woodstock & Bathurst (the later has since left sighting the Dubbo influence on returns as the main reason in discussions with our members)

The Cowra Woodstock Racing Pigeon Club has no issue with Dubbo or any other club for that matter transporting with the Midwest Federation and we see this transport assistance as an essential means of keeping the sport alive in country areas.

What we do need to do though is keep integrity in our Federation race results and keep on top of bird welfare for all clubs.

If the remaining Midwest Federation Clubs vote to continue releasing the Dubbo birds with the Federation birds our club will have to reconvene for another club meeting & reassess what we do in regards to the 2021 season and inform the federation of our decision at a later federation meeting
