1. Welcoming of Members

Chair welcomed members to the meeting - 40 Members Attended

2. Apologies – Nil

3. Presidents Report

The Chair provided an overview of the year past and commented on the number of challenges that both the Fed and all members have had to face in regard to, Rota Virus disrupted racing again.

He paid tribute to the committee who have all worked hard to keep the Fed functioning and thanked Peter and Debbie Field for the ongoing efforts in maintaining the truck and looking after the birds.

He advised members that there was only 1 Race cancelled this season due to lack of bird numbers. He acknowledged that there has been some negativity and disappointment with the last-minute change to abandon Blackall, and have a second liberation from Charleville, due to changing weather forecast on the Saturday morning.

He reminded members that this is a reality that we all must accept, that the liberation Committee will make changes, when necessary, to ensure that the birds are liberated in favourable condition in line with the liberation guide lines.

He further advised that on a couple of occasions we moved the schedule liberation date to avoid unfavourable conditions and by doling so achieved a successful race.

He spoke of great success that Malcolm and Richard had in 2019, taking out both "Flyer of the Year" and "Bird of the Year". He also acknowledged the great results achieved by Mal and Val Watters winning the First Charleville and trapping another 3 birds in good time and then coming 3rd in the second Charleville, and also clocking an additional 6 birds in good time. A great effort considering 10 Flyer in the first race and 9 flyers in the second did not trap in race time.

In closing the Chair reminded members that all the Executive and the Liberation committee are also flyers, who are working just as hard to get their birds away, as well as administering their duties to ensure that the Federation and races are conducted and managed in compliance with the Federations policies and procedures.

4. Secretaries Report

The Secretary advised members that despite the cancelation of the 1 race, and the failure to liberate from Blackall, he felt that overall we had a very successful race season.

He advised that he believes that the current liberation policy is working well, and the flexibility that it gives the liberation committee to change race days to ensure the birds are liberated in the best conditions was worked well.

He thanked our Sponsors; JM Produce and Jester Park for their ongoing support. He believes that the arrangements will continue and reminded members to support both venues.

He advised that regardless of some criticism, that gets raised from time to time regarding Liberation decisions, he assured the members that he is committed to doing the best he can, to keep the Federation in good condition. He made comment, that he may come across as a bit abrupt, "but that how I am".

He thanked Stan for his ongoing support and acknowledged the efforts and support Greg Jack has delivered in the past year, and continuing to keep doing 2 important positions, which requires a lot of work behind the scenes to keep the Federation running smoothly.

Mick Watt for is his ongoing efforts in sorting out race results, trophies and prize cards, and the work associated with the liberation committee. Mick, and with Bill Collins providing considerable advice, decisions and support, regarding liberation issues make up a great team. I look forward to a great 2020 season.

5. <u>Treasurer's report</u>

The Treasure advised that the Federation is in a good financial position. He has identified some areas where we need to adjust the cost associated with mid-week tossing, but believes, with the number of flyers that have advised they will be flying next season, the Fed fees can stay the same for next year.

This no doubt is subject to no drastic changes in membership, flyer numbers, or unforeseen cost increases with Truck maintenance and fuel, etc, between now and the start of the race season.

There a couple of motions that will be discussed later in the meeting to gain approval for such changes as proposed.

He advised that the majority of club Treasurers are deposit monies electronically which has been a big improvement on last year.

He commented that Val Watters and Sandy Archer have been doing and excellent job, where all deposits are clearly identified, which is followed up by an email providing all details and a breakdown of such deposits. Great Work.

He further advised that he will continue to analysis all the Federation costs to ensure that we keep cost to minimum.

Notes: This schedule includes the dates of ECDRC races. The last one Blackall, is included in the LD Point score. We have the opportunity to reduce our cost by at least 50%, as we have been approached by the ECLDRC to transport their birds to Blackall. This schedule also supports the proposal to have the first round not included in the point score, and to have 6 sprint, 6 middle and 6 long distance races to make up a fairer overall point score. This also supports the breeder plates and Blue & Gold band races to be held on the same weekends, with a 3 week break between the Blue and Gold band Breeders plates races.

d) Increase fed , club and combine <u>bird limits to 30 birds for all Friday night basket</u> races in the <u>first round</u> (5 races in total).

I propose we do this to allow us more opportunity to better educate our birds. This small change will allow 30 more birds to be educated in the early races (this effectively adds almost 2 races of bird education to the schedule without adding any cost). The truck will be nowhere near full in the first round and this will help with cover and bigger liberations and as it is only for a very small amount of races, should not disadvantage the smaller flyer at the start of the year and these races are proposed to not be part of the overall fed average anyway.

I am not proposing the actual bird limits in baskets goes above 24- just that we use more baskets for these 5 races

Moved By R&M Clement, Seconded by Tony Davis

Mal Clements and Tony Davis spoke in favour of the motion. The was some general discussion as to the reason why this was proposed. There was some concern that this my reduce the room on the truck for surplus. There was also some concerns with basket allocations.

The Chair advised that there has been enough discussion, and call for a vote by show of hands. 19 For, 13 Against, Motion Passed with a majority of 6.

Note: The Chair advised that we will sort out basket allocations for the first and second rounds once we have conformation on the number of flyers.

e) Introduce a new flyer (restricted to new flyers with under 3 years flying experience) and junior flying members fee structure (Junior members must be under 21 and flying in their own right)

The new or junior member would have 4 options available to him or her in their forst 3 years of racing

Level 1-25% of listed fed fees that allows the flyer to race the first round and up to the end of the sprint series in round 2 (11 races)

Level 2-50% reduction of listed fed fees that allows the flyer to race up to and including the end of the mid distance series in round 2 (18 possible races in total).

Level 3- half fees- half basked for full season (12 bird limit)

Level 4 – full fees- full basked – full season

Logic is, very few first-year flyers get anywhere near the distance races and this would encourage people to try flying at reduced costs and would support and encourage juniors

After a short discussion, the Chair call for a vote by show of hands. All in favour, 0 Against, Motion Passed

f) I hereby move that the NCF adopt a split race basket fee as an ongoing system from the 2020 racing season. Allowing all members, the options of flying a whole basket or a half basket each week from every race point. This would allow new and smaller flyers a chance to race and enjoy the sport at a more economical rate. The federation would most likely be in a better financial situation as a result. This would attract more flying members and I know for sure from speaking with several people recently that there is plenty of interest in this option.
