• Quality of Rings

Terry Condran advised the meeting that a number of blue band rings and some gold rings were fading to the point that the number is no legible. Paul Bettens and Tim Fairfax also advised that it is mainly the blue rings, and that were lacking in quality were in some cases the numbers are hard to read or are partially cover, the resin coating is not even and is cracking allowing water in, and the insides of the ring are rough and need to file prior to fitting.
