If submitting your application by post please include your telephone and / or email address so the NRC can acknowledge receipt. The submission of an application does not guarantee success and is subject to ring availability (the number of rings available is limited) and a compliant application. Please include the competing loft address and competition name in block letters for example: CREE & SMITH, 87 NAIRN ROAD, MORAYFIELD, QLD 4506.

Please ensure all fields are completed or your application will be rejected and you will be required to re-apply in full. You can apply for more rings as many times as you wish in either your name or another syndicate's name. When an

application is accepted, you will be notified of the acceptance with a reference number by email, telephone or alternatively SMS. Within 7 days you must settle the account in cash or transfer funds to:

Under your name, the syndicates name or the racing name for example: IAN CREE or if a syndicate CREE & SMITH.

If the total payable funds are not transferred within seven working days the application expires and becomes invalid.

Payment is to be in full for the total price of a ring (\$40) and not for example 50% (\$20) if part of a two flyer syndicate. NRC bears no responsibility on any matter between syndicate members. When funds are received you will receive an email or SMS notification of the ring numbers allocated and a reference number to you via email, mail or NRC representative.

The distribution of rings will be arranged by the NRC's committee members or delegates. The NRC will strive to distribute rings in the most efficient and practical way possible.

# **Inaugural 2018 Ring Race**

### **Terms & Conditions**

- Race point is Red Head NSW currently planned for Saturday 1<sup>st</sup> September 2018 an approximate distance of 640km. Basketing will be on the Thursday prior at 7pm Zammit Oval, Deception Bay. Interstate flyers are most welcome but must race via lofts transporting with the NRC.
- 2. Race conditions are as per NRC rules.
- 3. Eligible lofts must be located North of the Brisbane River and South of the 'Big Fish'. An application for exemption can be made to the Ring Race Committee for consideration.
- 4. Rings restricted to 1000.
- Liberation will be determined by the NRC Liberation Committee. If conditions are not ideal, preference is for a holdover or cancellation but not a change in location / distance.
- 6. Liberation will be a separate release ½ hour after the Combine release.
- 7. Syndicates: prize money to be paid 50% to breeder and 50% to race loft. NRC race rings are to be paid for by the breeder. The breeder is to advise the NRC of the eligible loft that will race the birds at the time of ring purchase.
- 8. Total prize money awarded to the first 5 positions will be 1<sup>st</sup> 50%, 2<sup>nd</sup> 20%, 3<sup>rd</sup> 15%, 4<sup>th</sup> 10% and 5<sup>th</sup> 5%. Total prize money and payout amounts are determined by the number of paid up entries.
- 9. PMV inoculation is not required.
- 10. The requirement for ROTA immunisation is yet to be determined.
- 11. All prize money birds must be made available on request for inspection and / or tossing at the competitor's declared loft location by designated committee members (or appointee/s) after a provisional result is declared. If either of / or both of these two conditions is not met, the bird is disqualified.
- 12. Cut-off for ring purchases is 31<sup>st</sup> March 2018.
- 13. The 1<sup>st</sup> prize winner/s must make themselves available for interviews for media purposes and to promote the

- race and sport before prize money is provided.
- 14. No limit on entries per purchaser / breeder, syndicate or flyer.
- 15. No limit on prizes per purchaser / breeder, syndicate or flyer.
- 16. Ring cost is \$40
- 17. Rings are to be available from 1<sup>st</sup> July 2017.
- 18. Entries are only valid upon payment and NRC authorisation via an email or SMS message.
- 19. Race co-ordinates are to be verified.
- 20. The administration of drugs to racing pigeons with the purpose of enhancing race performance is not permitted. The committee at its discretion may arrange for testing to determine if drugs are being used. Prize money will be paid upon a negative result.
- 21. NRC Inc. does not enter into any dispute regarding syndicates of any type. NRC regards the competing birds to be the property of the breeder.
- 22. Impartial race supervision to be nominated; on a request in writing signed by not less than one-third of the total purchasers / breeders, syndicates or flyers.
- 23. Clocking may be by either electronic or manual means.
- 24. No qualifying races are required but are recommended by the NRC Inc.
- 25. Purchaser Declaration is required as having have read and agree to abide by; North Road Combine's Code of Conduct
- 26. Flyer Declaration is required that the loft resides within the defined boundaries and have read and agree to abide by; the North Road Combine's Code of Conduct, Transportation and Liberation Guidelines, Flying Rules and have been accepted for and paid the annual subscription (in full) for either an Invitation / Novelty Race, Life or Flying membership.
- 27. By providing a signed application you are considered to have accepted all of the NRC Ring Race terms and conditions.
