No motion be accepted for the change of a race direction or race survey method. for those races conducted by the SCF (in that direction) for the following year after the 1st of July (or when the life rings become available for sale) e.g., SCF. racing conditions for 2008 cannot be altered after the 1^{st of} July 2007

Keep paragraph 2. Which now reads

When racing has commenced, or will soon commence, and actions or conditions occur that will make racing the agreed program impossible to continue e.g (pigeon health restrictions. fire. Government rulings, force majeure) a ballot will be conducted, of all members for the approval of the change as per constitution.
