8 Auditor's Report – Steve Saywell presented the Auditor's Report to the Meeting

Julie,

Please accept the following audit report on the financial activities for the SCF Inc during the calendar year ending on 31<sup>st</sup> December, 2023. The audit consisted of a review of the bank statements, income and expenditure statements, receipts and monthly reconciliation statements for 2023 as presented by the SCF Treasurer.

During the operating calendar year 2023 the accounts were reconciled each month. This enabled easy and accurate assessment of the accounts and their reconciliation with the SCF Bank accounts as of 31<sup>st</sup> December, 2023.

The SCF accounts and bank records, as presented to me by the SCF in my opinion reflect an accurate and true copy of business conducted by the SCF Inc during 2023. The only anomaly in the accounts was the amounts paid out for the 2023 IGBF Prizemoney. The 2022 Balance Sheet liabilities noted an amount put aside for the 2023 IGBF Race. This amount was used to determine the prizemoney for the 2023 race. During this audit it was noted that there were deposits in 2023 for Income of sales of IGBF rings for the 2023 race. This income was not included in prize allocated for the 2023 race. The sum in question was \$360. That money has since been allocated to the prizes for this race, the prizes have been amended and the correct funds have been presented to the prize winners. This will be noted in the 2024 accounts as an expense for the 2023 season.

The 2023 Balance Sheet shows a significant reduction in funds for the fiscal year. This is directly related to the purchase of a new truck, \$154,000. There were presentations to the membership to gain approval for this expense in 2022 and 2023. The targets set at those presentations have been met with a truck being built to budget and delivered on time. The new Isuzu truck is approx 35% more fuel efficient than the previous truck and this enabled the SCF Management Committee to review racing expenses during the year and provide members with a freight refund that reflects this reduction in operating costs.

The SCF Management Committee has met the challenges of 2023 and although it has been difficult year, they have performed their duties to the benefit of the SCF membership. The SCF Secretary and Treasurer have demonstrated during the year a dedication and efficiency in how they carried out their roles that should be commended by all members of the SCF.

### Dapto Homing Pigeon Club SCF 2024 AGM Notices Of Motion

At a club meeting held 09 January 2024, the members of Dapto Homing Pigeon Club discussed potential notices of motions to put before the SCF 2024 Annual General Meeting (AGM). Please table the following motions to be discussed at the AGM and to be put to a ballot of all SCF members.

**Motion 1** – Replace the existing Racing & Clock Rules 47-47c. regarding the weekly SCF pointscore.

**Current Rules** are (mislabelled as): **47.** The Weekly SCF Pointscore system to be determined by the following allocation of points:

Flyers are awarded points corresponding to their actual finishing position in that Federation Race. 48a. Flyers not flying that SCF Race are awarded the corresponding points for the maximum number of SCF flyers for that season.

48b. Flyers not clocking in a SCF Race are awarded the corresponding points for the maximum number of flyers in that SCF Race.

48c. Positions are determined with the lowest points the winner.

**Replacement Motion: 47.** The Weekly SCF Pointscore system to only commence on the first Thursday night basketing race and to be determined by the following allocation of points: Flyers are awarded points corresponding to their actual finishing position in that Federation Race. 20 points to be awarded for first place, down to 1 point for 20th place.

47a. Flyers not flying that SCF Race are awarded no points.

47b. Flyers not clocking in a SCF Race are awarded no points in that SCF Race.

47c. Positions are determined with the highest points the winner.

Motion 7 – Replace the existing Racing and Clock Rule 1 concerning the holding of the AGM Eligibility to Vote and Associate members not eligible to vote on racing matters. (Dapto Homing Pigeon Club Motion 2)

Motion 2 – Replace the existing Racing & Clock Rule 1 concerning the holding of the AGM.

**Current Rule is: 1.** Annual General Meeting to be held on the 1<sup>st</sup> Saturday of February each year prior to racing for that year.

#### Replacement Motion: 1 AGM & Voting

**1a.** The Annual General Meeting to be held on the 1<sup>st</sup> Saturday of February each year prior to racing for that year.

**1b.** Éligibility to vote at the AGM, general meetings and in SCF ballots requires a member to have paid their membership fee for the current membership year. The membership year begins on 1 June each year and memberships expire on 31 May.

1c. Associate members of the SCF are not eligible to vote on racing matters.

**Motion 3** – Replace the existing Racing & Clock Rules 7a-7d. concerning the routes/direction of racing.

#### Current Rule is: 7. Racing Routes:

7a. The SCF Inc. of NSW shall conduct races on the basis of two years on the Northern Route followed by two years on the Southern Route and two years about alternatively thereafter. As soon as possible the SCF Committee shall draw up a schedule of races for the relevant season.

7b. Northern Route: To be defined as those race points flown along the coastline north of The SCF boundary with small deviations inland to accommodate a practical liberation from the appropriate point selected for that distance.

7c. Southern Route: To be defined as those race points flown along the coastline south of The SCF boundary with small deviations inland to accommodate a practical liberation from the appropriate point selected for that distance.

7d. Distances over 650 – 700km cannot be practically flown from the mainland along the southern coastline. Therefore, races past this distance will be selected from a different direction by the SCF Committee.

#### Replacement Motion: 7. Racing Routes:

7a. A discussion will be held each year at the AGM regarding potential race routes for the following years racing. A choice of three most popular routes will then be put to a ballot of eligible members to vote on as soon as practical after the AGM. A preferential voting system will be applied whereby members rank the three options in order of preference. When the SCF Committee tallies the votes, those members that voted for the least popular route as first preference, will have their second preference route counted in the ballot.

7b. Northern Route: To be defined as those race points flown along the coastline north of The SCF boundary with small deviations inland to accommodate a practical liberation from the appropriate point selected for that distance.

7c. Southern Route: To be defined as those race points flown along the coastline south of The SCF boundary with small deviations inland to accommodate a practical liberation from the appropriate point selected for that distance.

7d. Distances over 650 – 700km cannot be practically flown from the mainland along the southern coastline. Therefore, races past this distance will be selected from a different direction by the SCF Committee.

Motion 9 – Replace the existing Racing and Clock Rules 61-61a – use GPS to set clocks verified by two time applications (Dapto Homing Pigeon Club Motion 4)

Steve spoke about the GPS system varied by up to 2 seconds when compared to another two systems. Woonona Bulli and Towradgi have had difficulties with accessing the GPS system because of the location of their club house on the escarpment and during bad weather.

Ian Sunlay, start of the season set the master timers.

Alan Zahra, said it could take up to 10 minutes to connect to GPS.

**Motion 4** – Replace the existing Racing & Clock Rules 61-61a. concerning setting of clocks.

**Current Rule is: 61.** All clocks in combine races to be started and checked to the timing pip of the phone time available on number 1194.

61a. Members arriving late on clock setting night may have their clock set up to one hour late. On checking off night all clocks are to be struck off at the designated time. Late arrivals on clock checking night are to be disqualified. In the event of extenuating circumstances, the matter may be referred to the SCF Committee on appeal.

**Replacement Motion:** 61. All ETS clocks in Combine races are to be started and checked using a GPS where the ETS system allows this. The time on the club system set by GPS to be confirmed against two approved time websites provided by the SCF Committee. If the club system shows a variation against the website time, the GPS is to be reset. Non ETS systems are to be set and checked against verified club system times or approved time websites.

61a. Members arriving late on clock setting night may have their clock set up to one hour late. On checking off night all clocks are to be struck off at the designated time. Late arrivals on clock checking night are to be disqualified. In the event of extenuating circumstances, the matter may be referred to the SCF Committee on appeal.

Motion 10 – Replace the existing Racing and Clock Rule 62d concerning reading of clocks on 2 day races – Combine clocks checked at time of club's choosing. (Dapto Homing Pigeon Club Motion 5)

**Motion 5** – Replace the existing Racing & Clock Rule 62d. concerning reading of clocks on 2 day races.

Current Rule is: 62d. Clubs are to check clocks at 8:00 PM on the second Day in the case of 2 day races.

**Replacement Motion:** 62d. Clubs are to check Combine clocks at a time of their choosing in the event of 2 or more day races, unless directed to check the clocks at a central venue.

Motion 11 – Replace the existing Racing and Clock Rules 23a and 24-24b concerning how race entry and results sheets may be provided to the SCF Race Secretary – separate entry for each flyer and digital copies of entries and results allowed (Dapto Homing Pigeon Club Motion 6)

**Motion 6** – Replace the existing Racing & Clock Rules 23a & 24-24b concerning how race entry and results sheets may be provided to the SCF Race Secretary.

**Current Rules are 23.** All SCF Inc. of NSW Race Entry Summary Sheets must be in the hands of the SCF Inc. of NSW Race Secretary by the morning of the day after basketing.

23a. All SCF Inc. of NSW members entering an SCF Inc. of NSW Combine are to fill out a separate Combine Entry Race Form which is to be forwarded along with the Race Entry Summary Sheets to the SCF Inc. of NSW Race Secretary by the morning of the day after basketing.

24. All clock rolls and race entry forms must be in the hands of the SCF Inc. of NSW Race Secretary or race details phoned through by 10:00 PM on day of clocking in.

24a. All clock rolls and race entry forms must be delivered in a sealed envelope (signed and stamped by the club clock committee) or those results may be liable for disqualification.

24b. For those clubs phoning through the results the clock rolls and race entry forms must be delivered to the SCF Inc. of NSW Race Secretary within 3 days (usually Tuesday) of the completion of the race.

**Replacement Motion - 23:** All SCF Inc. of NSW Race Entry Summary Sheets must be in the hands of the SCF Inc. of NSW Race Secretary by the morning of the day after basketing. 23a All SCF Inc. of NSW members entering an SCF Inc. of NSW Combine are to fill out a separate Combine Entry Race Form which is to be forwarded along with the Race Entry Summary Sheets to the SCF Race Secretary or Assistant Race Secretary by the morning of the day after basketing. Digital copies of entry forms may be provided in lieu of the original paper form.

24: All Combine Race clock rolls or ETS clock result print-outs must be in the hands of the SCF Race Secretary or Assistant Race Secretary or race details entered on the SCF website by 10:00 PM on day of clocking in.24a. All clock rolls and ETS clock result print-outs must be delivered in a sealed envelope (signed and stamped by the club clock committee) or those results may be liable for disqualification. 24b. For those clubs entering results on the SCF website, the clock rolls and ETS clock result print-outs must be proved to the SCF Race Secretary or Assistant Race Secretary within 3 days (usually Tuesday) of the completion of the race. Digital copies of clock rolls and ETS results may be provided in lieu of the original paper form.
