The number of pigeons per basket was worked out using Van Breeman's calculations.
- The removal of the 5% taking of monies from combines. The committee accepts the point of the motion as it is. This rule will be removed as of the 2013 race season. It was also believed that the motion was out of order as the fees for racing etc. are set by the management committee.
