### **General Business**

Discussed the letter from Dapto re a bird having to Qualify for the longer races. Minimum race point off the South will be Mallacoota for yearlings with old birds to be exempt. As it is expected that they would have flown the precious season.

Foam on roof has been re-glued as some was starting to come loose.

Phillip Island 500 ring race has sold well with 300 rings sold to date. All SCF allocated rings are sold. There are 100 for the SPF and 100 to the old FRP.

Prize money breakdown will be 75% stays in each section with 25% for outright.

If no birds home in race time than the money will Jack Pot to the next year. Only those that bought rings in the race are eligible for the jack pot. Any new ring purchases are only eligible for that year's race pool.

President thanked everyone for the effort that was put in to the Charity event.
