#### **General Business**

The clubs and flyers are responsible for ensuring their birds are healthy and well enough to race.

**Nominations** – Nomination numbers are needed by **30 April 2023**. Any alterations to nomination numbers will be accepted up to two weeks before racing by **Saturday, 13 May 2023**. The SCF Committee will not be able to calculate the cost per bird until the final nominations are received.
