3. 2010 freight system

Confirmation of system for 2010 as per last meeting of August 09

The freight charge system introduced in 2009 was a resounding success in filling the truck with race birds at the lowest possible price. For 2010 the same system will continue with the following adjustments:

- Short distance nomination/allocation to include Old Bar.
- Long Distance nomination/allocation to start from Kempsey
- Nomination numbers for both series to be locked in prior to start of race season.
- If room is available on the truck for the Long Distance nomination members can increase their nominated numbers.
- This can only be done prior to the start of the Long Distance nominations.
- The cost for the extra nominated birds will be \$2 per bird per week for the whole series.

4. Kiama Trust Fund

Verbal confirmation from Anne Dawes, the only surviving Kiama member, was that the monies held in trust by the SCF for Kiama club be directed to the sponsorship of a perpetual Trophy for middle distance weekly points score. Written confirmation will be supplied by a letter from Anne Dawes.
