Release of non-racing birds on race day.

The SERPC Inc. has no rules governing the release of non-competing race birds by its members on race day. MOTION - BYRNE

From the time of liberation and thereafter for the duration of a current race in which members of the SERPC Inc are competing all other members of the SERPC Inc are not to release their own pigeons not competing in the current race either around their home loft or from any other point (tossing).

All members of the SERPC Inc are allowed to exercise and/or toss their pigeons before any scheduled race has been commenced.

Any member/s who breach this rule will be subject to usual disciplinary processes for the SERPC Inc.

SERPC Inc Race Rules @ at 3 states.

SURPLUS BASKETS & BIRD LIMITS

"The bird limit for any race conducted by the South East Racing Pigeon Combine shall be determined by.

- 1. The number of fliers
- 2. The period of confinement (overnight or longer)
- 3. The space available in the club's transport in accordance with the recommendations made by the Australian National Racing Pigeon Board for the transport of racing pigeons.

The bird limit for any racing participated in by the South East Racing Pigeon Combine when the transporting federation or combine is not the South East Racing Pigeon Combine will be whatever that transporting federation or combine determines."

BA – Excess birds for members creating an advantage tor those members. Should be made fairer by introducing a bird limit which I think should be 30 or 40 birds starting from 2024 race season. I have put motion forward based on discussions with other members about bird limits.

MB – I initially agreed with that as a way to ensure those with fewer birds can get more racing in rather than sending most birds each week however upon reflection who am I to tell a person how to manage his loft. By imposing a limit and reducing the number of race birds we will be telling all fliers how to manage their own lofts. We have the room in our trailer for more birds. I like to breed more birds to cater for the falcon around the box, whilst tossing and racing. If I have a good year I have more numbers, if the falcons are active then I have less. If we impose a limit, then we should allow surplus birds which is another discussion for another day.
