SPECIAL NOTICE 6th Feb 2017

Currently the SCF have been advised that ROTAVIRUS has infected numerous lofts in the Central Cumberland Federation and has increased to extreme numbers, these numbers were confirmed by Vet Mark White. At the SCF AGM the SCF Committee cautioned SCF Members as to the SCF recommendations put in place late last year.

Caution should be practised with regards LOFT BIO SECURITY, VOLUNTARY LOCK DOWN and NO TRANSFER OF BIRDS or EVENTS THAT INCLUDE NUMBERS OF PIGEONS AND MEMBERS IN THE SAME AREAS, eg Breeders Plates, Auctions, Races, etc. These are Voluntary measures as of today, 19th Dec, 2016 and could change without notice.ALL SCF SECRETARIES and the SCF Committee have had ample information for the SCF Membership to keep a current handle on any information that comes to hand. This information sharing is active and ongoing and up-dated often.

It is vitality important that the SCF Secretaries are in contact with their CLUB MEMBERS and with detailed information that is current due to the nature of this VIRUS now in NSW.

SPECIAL NOTE:

Also from the SCF AGM, the SCF Committee has made no commitment with regards Racing in 2017 and will be guided at all times by Professional Advice.

The SCF Committee has the welfare of both SCF Members and their birds to consider and as such have convened a SPECIAL MEETING for the 8th APRIL, 2017 at the FRAT 1PM Sunken Lounge.
